We are an international platform of institutions and organizations that understand controlling as a core element of sustainably successful management.

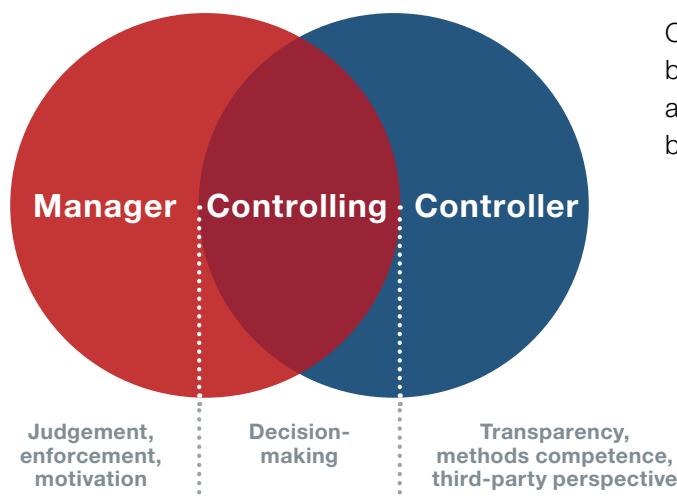
We develop, coordinate and disseminate
